AGREEMENT TO EXTEND AND MODIFY TEMPORARY RESTRAINING ORDER

Pursuant to Tex. R. Civ. P. 11, PLAINTIFF, THE STATE OF TEXAS, and DEFENDANTS MARQUE LEARNING CENTER PARTNERSHIP; GUERRA MANAGEMENT GROUP, INC., FKA MARQUE LEARNING CENTER; GUERRA PRODUCTS COMPANY, INC.; MARQUE LEARNING CENTER (NON-PROFIT); HENRY GUERRA, JR.; HENRY GUERRA, SR.; MICHAEL GUERRA; REBECCA GOMEZ GUERRA; ESTHER GOMEZ TRISTAN; ALFONSO MENDOZA; LINDA RUTH GARZA;

LAURO GARZA; GUERRA INTERNATIONAL (NON-PROFIT); AND BLANCA ESTELLA GUAJARDO ("Defendants") enter into the following agreement ("Agreement"):

The undersigned Plaintiff and Defendants (the "Parties"), by and through their counsel, agree as follows:

1) The *Ex Parte* Temporary Restraining Order, entered by the Ancillary Judge on December 5, 2014 ("TRO"), is extended by this Agreement until January 12, 2015. The terms of the TRO shall remain in full force and effect until January 12, 2015, at 5 p.m. Central Time, unless otherwise modified by the Court, by this Agreement, or by other written agreement signed by the parties' counsel.

2) Beginning December 12, 2014, until January 12, 2015 at 5 p.m. , , Defendants agree the location of the business operation known as Marque Learning Center, at 11811 East Freeway, Suite 130, Houston, Texas 77019 (or successor businesses operated by any of Defendants) shall remain closed, and Defendants shall not

a) offer for sale or rent any products or services of the business known as Marque Learning Center (or its successor) at the location at 11811 East Freeway, Houston, Texas 77029 or any other location;

b) sell any products or services of the business known as Marque Learning Center (or its successor) either online or at the location at 11811 East Freeway, Houston, Texas or any other location;

c) accept any monies, credit card payments, or other forms of payment from consumers for any products or services of the business known as Marque Learning Center (or its successor);


d) accept any new students for the business known as Marque Learning

Center (or its successor).

3) The previously-noticed deposition of the Corporate Representative of MARQUE LEARNING CENTER PARTNERSHIP; GUERRA MANAGEMENT GROUP, INC., FKA MARQUE LEARNING CENTER; GUERRA PRODUCTS COMPANY, INC.; MARQUE LEARNING CENTER (NON-PROFIT); and GUERRA INTERNATIONAL (NON-PROFIT), scheduled for December 12, 2014, is postponed until January 6, 2015 (an amended notice will be issued. The deadline for Defendants to produce documents under paragraph 14(e), (f) and (g) of the TRO and the documents requested in Exhibit B to the subpoena duces tecum attached to the Notice of Deposition of the Corporate Representative is extended to December 31, 2014 at 5 p.m.

4) The Parties agree to pass the temporary injunction hearing currently scheduled for December 19, 2014, at 1:30 p.m. The Parties agree that in the event the temporary injunction hearing cannot be re-set before January 12, 2015, due to the Court's schedule, the TRO and this Agreement shall remain in full force and effect until the temporary injunction hearing is rescheduled and completed.


