Re: Request for information relating to a March 12, 2004 shooting on Truett Street in McKinney

Dear Ms. Ladd:

The Office of the Attorney General has received your request for a ruling and assigned your request ID# 201767.

The City of McKinney Police department, whom you represent, received requests for the following information pertaining to an incident of multiple shootings: an audiotape of a 911 call, the transcript of the call, radio traffic recordings, incident reports, and warrant returns. You state the department has no transcripts. You have submitted the radio traffic recordings and the 911 call. To the extent the remaining information exists, we assume you have released it. Gov't Code §§ 552.301, .302. After reviewing your arguments and the submitted information, we have determined that your request does not present a novel or complex issue. Thus, we are addressing your claims in a memorandum opinion. You claim that the submitted information may be withheld from the requestor pursuant to section 552.108(a)(1) of the Government Code. We have considered your arguments and the submitted information and have determined that in accordance with section 552.108(a)(1) you may withhold the information.
