**AGREED FINAL JUDGMENT**

This is an action brought by Plaintiff Dallas County to challenge Letter Ruling OR2015-20455 (the "Ruling"). Dallas County received a request from one of its employees, an elected Dallas County Constable, for documents in the personnel file of a named employee regarding a workers' compensation claim. The Attorney General ruled that this request was made by the Constable in his official capacity and not as a member of the public.

The Attorney General went on to say that the requesting Constable has a special right of access to the documents in question. However, the parties agree that because the request was made by a person acting in his official capacity and not as a member of the public, it is not a request under the Public Information Act. Therefore, the parties agree that Letter Ruling OR2015-20455 should be withdrawn.

**IT IS THEREFORE ORDERED that:**

1. Letter Ruling OR2015-20455 be withdrawn. Letter Ruling OR2015-20455 should not be cited for any purpose as a prior determination by the Office of the Attorney General under Tex. Gov't Code § 552.301(f).
2. All costs of court are taxed against the parties incurring same.
3. This cause is hereby DISMISSED.


