SECTION 2 – IDENTIFY AND DESCRIBE CATASTROPHE

If the catastrophe impact is longer than seven calendar days, a governmental body may submit an extension notice at the end of the initial suspension period. A governmental body may only file one extension notice, and the extension notice may not exceed seven consecutive calendar days. *See* Gov't Code §552.233(d), (e).
