## SECTION 1 – GOVERNMENTAL BODY IMPACTED BY THE CATASTROPHE

#### **GOVERNMENT CODE § 552.233**

Pursuant to section 552.233(b), a governmental body may suspend the applicability of the requirements of the Public Information Act (the "Act") if the governmental body is currently impacted by a catastrophe and provides proper notice in accordance with this section.

### SECTION 2 – IDENTIFY AND DESCRIBE CATASTROPHE

Section 552.233(a)(1) defines catastrophe as a "condition or occurrence that interferes with the ability of a governmental body to comply with the requirements of this chapter[.]" Identify and describe the catastrophe impacting the governmental body:

The Catastrophe is the COVID-19 pandemic referenced in the Presidential Declaration of a National Emergency, March 19, 2020, the Governor's Disaster Proclamation of March 13, 2020 and related Executive Orders, the Tyler Mayor's Declaration of Disaster dated March 20, 2020, as extended by Tyler City Council, and the County Judge of Smith County declaring a "Stay at Home" order on Friday, March 27, 2020 for all "non-essential" employees, as extended through April 30, 2020.

#### SECTION 3 – SUSPENSION PERIOD

The initial suspension period may not exceed seven consecutive calendar days. A governmental body may not submit a catastrophe notice more than two calendar days prior to the beginning date of the suspension period. If the catastrophe impact is longer than seven calendar days, a governmental body may submit an extension notice at the end of the initial suspension period. A governmental body may only file one extension notice, and the extension notice may not exceed seven consecutive calendar days. See Gov't Code §552.233(d), (e).

Please note: Governmental bodies may not submit the initial suspension notice and the extension notice at the same time or on the same form. For purposes of section 552.233, the first day (beginning date) and the end date of the suspension period are counted as part of the suspension period.
