The Domestic Violence High Risk Teams Grant Program supports the formation of domestic violence high risk teams which are multidisciplinary teams that coordinates efforts to increase the safety of victims of family violence by monitoring and containing perpetrators while providing victim services. The teams may be composed of law enforcement officers, prosecutors, community supervision and corrections departments, victim advocates, nonprofit organizations that provide services or shelter to victims of family violence, and medical personnel.
