If your order was issued before September 1, 2021, and you live 100 miles or less from the other parent, the noncustodial parenting time order may contain the schedule below:

Thursday parenting time pickup is 6 p.m. on Thursday and drop-off is $8 \mathrm{p} . \mathrm{m}$. This parenting time is only while school is in session.

Weekend parenting time pickup is 6 p.m. on the first, third and fifth Friday of each month. Drop-off is $6 \mathrm{p} . \mathrm{m}$. on Sunday of that weekend.

- If there is a school holiday, teacher in-service day, federal holiday, state holiday or local holiday on the Monday of one of these weekends, the drop-off is $6 \mathrm{p} . \mathrm{m}$. on Monday.
- If there is a school holiday, teacher in-service day, federal holiday, state holiday or local holiday on the first, third or fifth Friday of the month, the pickup is 6 p.m. on Thursday.


## BEFORE SEPTEMBER 1, 2021

## OVER 100 MILES

If your order was issued before September 1, 2021, and you live over 100 miles from the other parent, the noncustodial parenting time order may contain the schedule below:

Weekend parenting time pickup is 6 p.m. on the first, third and fifth Friday of each month. Drop-off is $6 \mathrm{p} . \mathrm{m}$. on Sunday of that weekend.

- Instead of the first, third and fifth Friday of each month, your order may have the alternative weekend parenting time. The noncustodial parent can have one weekend per month of the noncustodial parent's choice. The weekend pick up is 6 p.m. on the day school is dismissed and drop-off is $6 \mathrm{p} . \mathrm{m}$. on the day before school resumes after the weekend. The noncustodial parent must give the custodial parent 14 days notice in writing or telephone before the chosen weekend. The weekend chosen cannot conflict with parenting time during Christmas, Thanksgiving, the child's birthday, and Father's Day or Mother's Day.
- If you begin living over 100 miles apart after the order is signed, to elect the option for the alternative weekend parenting time above, the noncustodial parent must send written notice to the custodial parent within 90 days after you begin to reside more than 100 miles apart.
- If there is a school holiday, teacher in-service day, federal holiday, state holiday or local holiday on the Monday of one of these weekends, the drop-off is $6 \mathrm{p} . \mathrm{m}$. on Monday.
- If there is a school holiday, teacher in-service day, federal holiday, state holiday or local holiday on the Friday of one of these weekends, the pickup is 6 p.m. on Thursday.

## SEPTEMBER 1, 2021 OR AFTER 0-50 MILES

If your order was issued on or after September 1, 2021, and you live 50 miles or less from the other parent, the noncustodial parenting time order may contain the schedule below:

Thursday parenting time pickup is when your child is released from school and drop-off is the following morning when your child's school resumes on Friday. This parenting time is only while school is in session.

Weekend parenting time pickup is on the first, third and fifth Friday of each month when your child is released from school and drop-off is when school resumes on Monday.

- Pickup for weekend parenting time while school is not in session is 6 p.m. on the first, third and fifth Friday of each month and drop-off is 6 p.m. on Sunday of that weekend.
- If there is a student holiday or teacher in-service day on the Monday of one of these weekends, the dropoff is 8 a.m. on Tuesday. If there is a federal, state, or local holiday on the Monday of one of these weekends during the summer months while school is NOT in session, the drop-off is 6 p.m. on Monday.
- If there is a student holiday or teacher in-service day on the first, third or fifth Friday of the month, the pickup is Thursday when the child is released from school. If there is a federal, state, or local holiday on the Friday of one of these weekends during the summer months while school is NOT in session, the pickup is 6 p.m. on Thursday.

SEPTEMBER 1, 2021 OR AFTER 51-100 MILES

If your order was issued on or after September 1, 2021, and you live between 51 and 100 miles from the other parent, the noncustodial parenting time order may contain the schedule below:

Thursday parenting time pickup is 6 p.m. and drop-off is 8 p.m. This parenting time is only while school is in session

Weekend parenting time pickup is 6 p.m. on the first, third and fifth Friday of each month. Drop-off is 6 p.m. on Sunday of that weekend.

- If there is a school holiday, teacher in-service day, federal holiday, state holiday or local holiday on the Monday of one of these weekends, the drop-off is 6 p.m. on Monday.
- If there is a school holiday, teacher in-service day, federal holiday, state holiday or local holiday on the first, third or fifth Friday of the month, the pickup is 6 p.m. on Thursday.

SEPTEMBER 1, 2021 OR AFTER OVER 100 MILES

If your order was issued on or after September 1, 2021, and you live over 100 miles from the other parent, the noncustodial parenting time order may contain the schedule below:

Weekend parenting time pickup is 6 p.m. on the first, third and fifth Friday of each month. Drop-off is 6 p.m. on Sunday of that weekend.

- Instead of the first, third and fifth Friday of each month, your order may have the alternative weekend parenting time. The noncustodial parent can have one weekend per month of the noncustodial parent's choice. The weekend pick up is 6 p.m. on the day school is dismissed and drop-off is 6 p.m. on the day before school resumes after the weekend. The noncustodial parent must give the custodial parent 14 days notice in writing or telephone before the chosen weekend. The weekend chosen cannot conflict with parenting time during Christmas, Thanksgiving, the child's birthday, and Father's Day or Mother's Day.
- If you begin living over 100 miles apart after the order is signed, to elect the option for the alternative weekend parenting time above, the noncustodial parent must send written notice to the custodial parent within 90 days after you begin to reside more than 100 miles apart.
- If there is a school holiday, teacher in-service day, federal holiday, state holiday or local holiday on the Monday of one of these weekends, the drop-off is 6 p.m. on Monday.
- If there is a school holiday, teacher in-service day, federal holiday, state holiday or local holiday on the appropriate Friday, the pickup is 6 p.m. on Thursday.


## Holidays and Other Parenting Time

## Other important information

## APRIL 1 ANNUAL NOTICE, SUMMER PARENTING TIME

The noncustodial parent must give written notice to the custodial parent by April 1 if the noncustodial parent wants to have an extended period(s) of summer parenting time that differs from the dates provided in your parenting time order. The dates of the noncustodial parent's specified extended periods of summer parenting time must begin some time after the child's school is dismissed for summer vacation and must end at least seven days before school resumes at the end of the summer vacation. There can be no more than two separate periods of at least seven consecutive days each.

If you live 100 miles or less from the other parent, the noncustodial parent can designate up to 30 days for an extended period(s). If the noncustodial parent does not designate dates by April 1, the noncustodial parent has parenting time for 30 consecutive days in that year beginning at 6 p.m. on July 1 and ending at 6 p.m. on July 31. The noncustodial parent also has the regular occurring weekend parenting time during the rest of the summer.

If you live over 100 miles from the other parent, the noncustodial parent can designate up to 42 days for extended parenting time. If the noncustodial parent does not designate dates by April 1, the noncustodial parent has parenting time for 42 consecutive days in that year beginning at 6 p.m. on June 15 and ending at 6 p.m. on July 27.
The noncustodial parent also has the regular occurring weekend parenting time during the rest of the summer.

## APRIL 15 ANNUAL NOTICE, SUMMER PARENTING TIME

The custodial parent must give written notice to the noncustodial parent by April 15, designating the weekend the custodial parent wishes to see the child(ren) during the noncustodial parent's extended summer parenting time. This weekend begins at 6 p.m. on Friday and ends at 6 p.m. on Sunday.

> For parents living over 100 miles apart, the custodial parent may designate a second weekend during the noncustodial parent's extended period of possession if the noncustodial parent's summer parenting time period exceeds 30 days.

Additionally, the custodial parent can designate 21 days of the custodial parent's extended parenting time when the noncustodial parent cannot have weekend parenting time. To do this, the custodial parent must give written notice to the noncustodial parent by April 15 of the dates. These dates must begin after the child's school is dismissed for the summer vacation and must end at least seven days before school resumes at the end of the summer vacation. This time cannot be more than two separate periods of at least seven consecutive days each. Each of these periods begin and end at 6 p.m. The weekend and extended summer parenting time by the custodial parent may not interfere with the noncustodial parent's extended summer parenting time period(s) or with Father's Day if the noncustodial parent is the father.

CHILDREN NOT ENROLLED IN SCHOOL
If your child is not enrolled in school, when school is referenced, you should use the schedule for the local public school district your child would attend, based upon where your child lives.
