## Texas Office of the Attorney General Names Conroe Child Support Employee Assistant Attorney General of the Year

Julie Conn was singled out as the region's top attorney for her dedication to Texas children

**CONROE** – The Office of the Attorney General recognized Julie Conn, an Assistant Attorney General (AAG) in the Child Support Division's Conroe office, for her commitment to Texas children. Conn was named Assistant Attorney General of the Year for the Child Support Division's Region 10. She was presented with the award on Monday, August 1, 2022, at the Statewide Assistant Attorneys General Virtual Conference.

Each recipient demonstrates a desire to serve Texas families, help their colleagues, and enhance the Attorney General's Child Support Division.

Conn, who joined the Office of the Attorney General in 2020, represents the State of Texas in legal actions to establish paternity between children of unmarried parents and their biological fathers. She also works to establish, enforce, and modify court orders requiring parents to provide child support, medical support, and dental support.

A graduate of the University of Texas School of Law, Conn was chosen to be the region's Assistant Attorney General of the Year for being an exemplary attorney, willing trainer, and strong leader. She has demonstrated the willingness to take on any task and provide wise legal direction to her co-workers. She has earned a reputation as a reliable leader.
