Texas Office of the Attorney General Names Waco Child Support Employee Assistant Attorney General of the Year

Kim Morris was singled out as the region's top attorney for her dedication to Texas children

WACO – The Office of the Attorney General recognized Kim Morris, an Assistant Attorney General (AAG) in the Child Support Division's Waco office, for her commitment to Texas children. Morris was named Assistant Attorney General of the Year for the Child Support Division's Region 7. She was presented with the award on Monday, August 1, 2022, at the Statewide Assistant Attorneys General Virtual Conference.

"I commend Kim for her hard work and dedication to improving the lives of Texas children and families," Attorney General Paxton said. "Kim represents the best, and it is attorneys like her that make this agency great. I am thankful to her for answering the call to serve the people of Texas."

One Assistant Attorney General was selected for this honor from each of the state's ten child support regions, along with an Assistant Attorney General from the Child Support Division headquarters office in Austin. Honorees are chosen based upon recommendations from their peers and supervisors, focusing on employees willing to go beyond their normal duties to serve Texas children. Each recipient demonstrates a desire to serve Texas families, help their colleagues, and enhance the Attorney General's Child Support Division.

Morris, who joined the Office of the Attorney General in 1998, represents the State of Texas in legal actions to establish paternity between children of unmarried parents and their biological fathers. She also works to establish, enforce, and modify court orders requiring parents to provide child support, medical support, and dental support.

A graduate of Baylor Law School, Morris was chosen to be the region's Assistant Attorney General of the Year for being an exemplary attorney, willing trainer, and strong leader. She has demonstrated the willingness to take on any task and provide wise legal direction to her co-workers. She has earned a reputation as a reliable leader.
