**Texas Office of the Attorney General Names San Antonio Metro Child Support Employee Assistant Attorney General of the Year**  
*Daniela Martinez singled out as region's top attorney for dedication to Texas children*

**San Antonio Metro** – The Office of the Attorney General recognized Daniela Martinez, an Assistant Attorney General (AAG) in the Child Support Division's San Antonio Metro office, for her commitment to Texas children. Martinez was named Assistant Attorney General of the Year for the Child Support Division's Region 2. She was presented with the award on Wednesday, July 26, 2023, at the Statewide Assistant Attorneys General Conference.

"I am honored to commend Daniela for her unwavering commitment and tireless efforts in support of Texas children and families," Angela Colmenero, Provisional Attorney General said. One Assistant Attorney General was selected for this honor from each of the state's ten child support field regions, along with an Assistant Attorney General from the Child Support Division State Office in Austin. Honorees are chosen based upon recommendations from their peers and supervisors, with a particular focus on employees who are willing to go beyond their normal duties to serve Texas children. Each recipient demonstrates a desire to serve Texas families, help their colleagues and enhance the Attorney General's Child Support Division.

Martinez, who joined the Office of the Attorney General in 2019, represents the State of Texas in legal actions to establish paternity between children of unmarried parents and their biological fathers. She also works to establish, enforce, and modify court orders that require parents to provide child support, medical support and dental support.

A graduate of St. Mary's University School of Law, Martinez was chosen to be the region's Assistant Attorney General of the Year for being an exemplary attorney, willing trainer and a strong leader. She has demonstrated the willingness to take on any task and provide wise legal direction to her co-workers. She has earned the reputation as a reliable leader.
