Re: Request for Opinion

Dear General Cornyn:

I have been asked by the Mayor of the City of San Antonio to seek an Attorney General's opinion on the question of whether the common law doctrine of incompatibility prohibits a member of the City Council from nominating himself to a board made up of citizens of the City of San Antonio who are appointed by the City Council if the ordinance establishing such board provides that an elected official may serve on such board. The following facts are presented:

- 1. On November 4, 1999, the San Antonio City Council passed and approved an ordinance creating the Greater Kelly Development Authority (GKDA) to oversee the redevelopment of Kelly Air Force Base as it moves from public operation to private ownership.
- 2. The GKDA Board is an 11-member body with each member of the San Antonio City Council nominating one member subject to the approval by the City Council as a whole.
- 3. To that end, a sitting member of the City Council, whose district includes Kelly Air Force Base, nominated himself to the GKDA Board of Directors.

4. This nomination was approved by the full Council along with the passage of the creating ordinance. Under this ordinance, "an individual who is otherwise eligible to serve on the Board is not ineligible because the individual is an elected official."

Enclosed a copy of Ordinance Number 90826, passed and approved on November 4, 1999, which establishes the GKDA and its Board of Directors.

In the past, the Attorney General has stated that if an ordinance is passed under statutory authority, it repeals the common law in all respects in which inconsistencies exist. (Op. JM-1087).

Another Attorney General's opinion held that a home-rule city may overcome common-law doctrine of incompatibility if the statute allowed for composition of the board to include elected officials. (Op. 96-064).

An expedited response would be greatly appreciated, as the Councilman in question has decided not to attend any of the board meetings, or be involved in any board functions, until your office has ruled on this matter.
